SGLT-2 INHIBITORS FOR TREATMENT OF HEART FAILURE AND CHRONIC KIDNEY DISEASE

Recorded webinar



PROGRAM OVERVIEW

This program will provide 1 hour of CE credit and is offered as a recorded webinar.

Large clinical trials involving patients with type 2 diabetes have shown that sodium–glucose cotransporter 2 inhibitors (SGLT2i) reduce the risk of heart failure hospitalizations by 30 to 35% and progression of renal disease by 35 to 50%. These cardiorenal benefits seem to be independent of glucose lowering capabilities by this class of medications. This presentation will evaluate the current evidence for use of SGLT2i in patients with heart failure (HF) and chronic kidney disease (CKD) both with and without type 2 diabetes, review pertinent HF and CKD guideline recommendations, and identify patients with HF and CKD who would be appropriate candidates for SGLT2i therapy.

Practice Site

At this practice site, Dr. McCoy practices in an interprofessional collaborative environment, providing education and management for patients with diabetes, hypertension, dyslipidemia, and cardiovascular risk reduction. Her research is also focused in these areas, with research projects evaluating the impact of pharmacist management on diabetes control in an interdisciplinary setting, pharmacist management of insulin pumps, and adherence to cardiovascular guideline recommendations.
