PROGRAM OVERVIEW

This continuing education program is a paper-based CE program. It provides an overview of programs offered by the Aging and Disability Resource Centers (ADRCs) and how Medicare beneficiaries can benefit from them.

If you are interested in learning more and/or joining the C.A.R.E.S. Pharmacy Network, you can complete the three ACPE approved one-credit-hour each CE articles or the three-hour video training program (3 CE credits) that is available free online. After at least one full-time pharmacist from your pharmacy has completed the 3 CE credits training you can be enrolled in the C.A.R.E.S. Pharmacy Network at no cost and will receive a referral kit to help you identify and refer Medicare patients who may benefit from community programs to a local agency.
