This 5 module course will provide new preceptors with an orientation on the following topics: 1) HCOP's mission, goals and values; 2) HCOP's practice-ready curriculum; 3) HCOP's IPPE and APPE program requirements and rotation objectives; 4) Individualizing APPEs based on student knowledge and experience; 5) Policies and procedures for difficult learning situations. This course should be completed by all new preceptors for HCOP's experiential program as initial training. An access code for this course will be provided by the Experiential Programs Office.
