PROGRAM OVERVIEW

The C.A.R.E.S. continuing education programs are designed for Alabama pharmacists and pharmacy technicians to provide an overview of Medicare and the roles of the Aging and Disability Resource Centers (ADRCs) with the primary goal to help pharmacists and pharmacy staff effectively and efficiently assist Medicare beneficiaries. All of our CE programs are funded by the Alabama Department of Senior Services (ADSS) and the U.S. Administration for Community Living. They are made available to pharmacists and technicians in Alabama at no cost. The programs are developed by Dr. Salisa Westrick, Professor of Health Outcomes Research and Policy in collaboration with the Alabama Department of Senior Services.

This paper CE program emphasizes the critical need for accessible healthcare and community resources for the rapidly growing older adult population in the United States, particularly in Alabama, where many older adults face financial struggles and health challenges. It highlights the role of community pharmacists and pharmacy technicians in raising awareness of these resources, especially for hard-to-reach individuals. The program aims to educate learners on the objectives and eligibility requirements of Aging and Disability Resource Centers (ADRCs) and identify local ADRCs for potential collaboration to improve older adults' health outcomes and quality of life.
